Data Controller

The controller responsible for data processing is Allianz SE with its registered office in Königinstraße 28, 80802 Munich, Germany.

Purposes and legal bases of data processing

a) When visiting our website

When you visit our websites (e.g. our portal for participant management or individual event websites), certain data is processed due to the transmission operation. We store this data in so-called log files. This includes the IP address, the start and end of the visit to our pages, the amount of data transmitted and the sub-pages that you have accessed.

We collect and store the log files in order to be able to carry out the technical process of provision of our websites. We also process the log files for security reasons in order to be able to trace cases of misuse of our service.

The processing of this data is based on our legitimate interests. Our legitimate interest lies in the above-mentioned purposes.

b) Registration for and participation in events

We collect and process your personal data in order to use it for the organization and execution of events and travels. For this purpose, we primarily use the master data stored by the respective company (e.g. name, address, communication data). In the online registration process for participant management, you have the option of confirming the accuracy of this data. Depending on the event or trip, it may be necessary to collect further data from you. This may include: Name, date of birth, academic title, a profile picture, business address, private address and (copy of) ID data (e.g. for a hotel booking), telephone numbers, information on food intolerances and food preferences (vegan/vegetarian), shoe size/body or garment size (participation in programs and supplementary questions for program implementation or provision of welcome gifts), consent to special instructions (e.g. taxation, code of conduct), first/last name of an accompanying person or the contact details of a person to be named by you for any emergencies. This information is only collected if necessary and may be requested from you when you register for the event. During the organization of travels and events, images and sound recordings may be made for documentation and public relations purposes.

The processing of this data is based on our legitimate interests. We can also ask you to give your consent to this processing. Our legitimate interest lies in being able to carry out the event or travels properly.

c) When registering for a digital event

If you register for a digital event, we will process your personal data required for the registration and execution of the event (in particular your name, business e-mail address, your function within the company if applicable, your mobile number or private or business address).

The processing of this data is based on the protection of our legitimate interests. Our legitimate interest is to be able to provide you with the digital event.

d) Other data processing based on legitimate interests and legal requirements

We also process your data if it is necessary to pursue our legitimate interests or the legitimate interest of third parties. This may be the case in particular:

- to ensure IT security and IT operations, in particular also for support requests,
- to prevent and investigate criminal offenses or violations of other legal norms and internal regulations, in particular through data analysis performed to prevent misuse
- to be able to trace and prove facts in the event of legal disputes,
- for the statistical evaluation of participant numbers.

In addition, we process your data to fulfill legal obligations (e.g. commercial and regulatory requirements, commercial and tax retention and verification obligations).

Categories of recipients of personal data

In order to achieve the above-mentioned purposes, it is in some cases unavoidable to transfer your personal data to other recipients to the extent necessary. These recipients may be contractors or, in rare cases, third parties. In any case, contractual provisions have been concluded with the recipients to ensure compliance with data protection regulations. Recipient in this sense are IT service providers for participant management (e.g. Big Picture S.r.l., Italy for the technical provision of a participant portal for online registration/deregistration as well as for comprehensive participant management and the operation of event websites) or the provision of technical solutions for online events.

Depending on the specific event and the resulting requirements, data must be transferred to selected service providers to the extent necessary. These may be, for example Hotel, travel agencies, airlines, shipping companies, transfer companies, caterers, photographers, advertising agencies, printers, advertising material manufacturers, event agencies, etc.

Data retention

In general, we delete your data as soon as it is no longer required for the above-mentioned purposes, unless temporary storage is still necessary. For example, we store your data due to legal obligations to provide evidence and retain data, which arise from the German Commercial Code (Handelsgesetzbuch – "HGB") and the German Fiscal Code (Abgabenordnung – "AO"), among others. The storage periods are up to ten full years. We also store your data for the period in which claims can be asserted against our company (statutory limitation period of three or up to thirty years).

Data transfer to a third country

Your personal personal data may be processed in countries outside the EEA. Transfers to Allianz Group companies outside the EU are based on our Binding Corporate Rules, available at https://www.allianz.com/en/privacy-statement.html. Where the Allianz Binding Corporate Rules do not apply we will instead take steps to ensure that the transfer of your personal data outside of the EEA receives an adequate level of protection. In this case we make sure that the transfer occurs on the basis of an adequacy decision or other safeguards, such as Standard Contractual Clauses, pursuant to Art. 46 (2) (c) GDPR.

In case of absence of an adequacy decision or other appropriate safeguards, transfer of personal data to third countries will take place either on the basis of your explicit consent or other statutory conditions (such as the fulfillment of a contract with you or in your interest between Allianz SE and another party, for the implementation of pre-contractual measures at your request or where the transfer is crucial for public interest reasons).

Your rights as data subject

You can request information on the processing of your personal data by sending us a message to the contact details specified above (see section "Data Controller"). You can also, under certain conditions, request the rectification or deletion of your data. You may also have the right to restrict the processing of your data and the right to data portability.

If you have given us your consent to process personal data for certain purposes, you can withdraw your consent at any time with effect for the future by sending the message to the contact details specified above (see section "Data Controller").

You also have the option of contacting a data protection supervisory authority. The authority responsible for us is The Bavarian State Office for Data Protection Supervision (Bayerisches Landesamt für Datenschutzaufsicht) in Ansbach.

Right to object

In case we process your data in order to pursue our legitimate interests, you may object to this processing on grounds relating to your particular situation. In this case we shall no longer process your personal data unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or when the processing is necessary for the establishment, exercise or defence of legal claims.
